Notes:

- Due to privacy considerations, the figures in this table have been subjected to rounding. Under this method, all figures in the table are rounded either up or down to multiples of *5* and all values between 0 and 5 are shown as "--". As a result of this rounding, data may not add up to the totals indicated.

- Data for 2015 and 2016 are preliminary estimates and are subject to change.

- Data excludes Resettlement Assistance Program (RAP) and does not include services used in Quebec.

- The table contains data entered by Service Provider Organizations (SPOs) up until the end of October 31st, 2016.

- Data reflects reporting by SPOs at the time of the tabulation. Reports, for the same period and produced at different times, may contain slightly different data. This occurs due to on-going data entry by SPOs, resulting in changes to counts. IRCC is actively reviewing data quality and integrity.

- Since a client can receive multiple services, it is possible for the sum of clients by service received to be higher than the total count of unique clients. The total unique clients row counts each client only once regardless of how many services they have received.
